4. Business Arising from previous meeting

a. Permit Term Discussion

Ms. Solman supported the idea of implementing a 5-year term for sign permits. At the end of 5 years, the business would need to reapply for their permit and pay the full application fee again. The process also provides Peterborough County with the opportunity to not renew permits for holders who have not been maintaining signs in good condition. For existing signs, simplify the reapplication process and have the 5 year term go into effect as of the passing of the by-law. The committee recommends an implementation of a numbering process whereby the sign permit number can be attached to the sign and eases the verification process to ensure the sign is being used by the permit holder. Discussion took place surrounding the annual fees, the amount and purpose thereof.


