
County Official Plan Project

Meeting Minutes – April 20, 2017 Technical Advisory Committee Meeting No. 1



Location: Committee Room, County Court House

Copies of the agenda, proposed work plan and public consultation strategy were distributed.

Items and issues discussed at the meeting were as follows:

Information Items

- Developing a new Official Plan rather than amend the current plan
- Presentation being made to Havelock-Belmont-Methuen in early May regarding this project, how Local Component functions

Purpose and Role of TAC

- Important to have involvement of all 8 municipalities since the broader County component of the OP is applicable to all
- TAC will assist in resolving issues and providing input, but also responsible for getting information back to the appropriate Township staff and Council, may be required to provide in-kind services (for example, meeting space for open houses or promotion of County OP notices)
- Seeking to obtain consensus on work plan and consultation strategy at this meeting
- TAC Sub-Committee made up of staff from Local Component municipalities (currently 5 Townships) to review local polices and land use schedules. Sub-Committee meetings may be more frequent due to level of detail.

Review of Proposed Work Plan

- Provided overview of work plan, which may be fluid and change over time; for example, there is potential for additional TAC/Sub-Committee/Council meetings on an as-needed basis, and website will be updated when necessary
- County requests that Township staff review local plans/initiatives and advise of recommendations from local studies to be incorporated, where appropriate, into the County OP

- County Growth Management Study is waiting for resolution to annexation issue, which has potential to change study figures; results will be discussed with TAC at later date
- TAC identified need to have presentations to local Councils earlier in process, additional open houses in non-Local Component municipalities, and release of TAC meeting minutes/County Council reports as information items for local Councils
- County seeking potential dates during summer to host initial open houses

Review of Public Consultation Strategy

- Based off of process established in work plan
- TAC suggested a print advertisement or media release together with launch of OP webpage, provide clarification or materials to public explaining what an OP is/does (common misconceptions around this)
- County seeking contact information for local interest groups or other parties who specifically request to be notified of Planning Act applications in local municipalities

MMAH Consultation

- County staff met with Ministry staff in March; topics of particular importance included new Growth Plan, agricultural areas, 30m setback, climate change, First Nations consultation
- Formal pre-consultation with MMAH and partner ministries to include TAC; important to hear first-hand what Provincial interests are and where direction is coming from. Date has been set for June 15th

Next Steps & Action Items

- TAC Sub-Committee meeting to be scheduled for week of May 29th
- County to follow up via email regarding contact information for special interest groups, recommendations from local studies/initiatives, tentative dates/locations for summer open houses
- County to release meeting minutes to TAC members for inclusion on Township Council agendas
- Presentation to County Council reviewing work plan, consultation strategy, MMAH meeting summary
- TAC pre-consultation with provincial Ministries on June 15
